

AFFIDAVIT

I, the undersigned PROF. Desiré Dubounet (previously known as William Charles Nelson, having my current address at Kalvariater 2, H-1089 Budapest, Hungary, born in Warren, USA on June 19th 1951, mother's maiden name: Helen Tuori), a retired US alternative medicine practitioner (the "Affiant")

HEREBY MAKE MY STATEMENT AND GENERAL AFFIDAVIT DULY SWORN UPON OATH AND AFFIRMATION OF BELIEF AND PERSONAL KNOWLEDGE

that the following matters, facts and things set forth herein are true and correct to the best of my knowledge:

Therefore, Mandelay's allegations and the said document of unknown origin (*Permission Notice*) are MISREPRESENTING my will and qualify as a MISAPPROPRIATION of my intellectual property, and the said document of unknown origin (*Permission Notice*) shall be NULL AND VOID IN PERPETUITY.
